# Protect Your Healthcare, Schools and Hospitals

The U.S. Senate is moving to approve **\$800 billion in cuts** to Medicaid that have already passed the U.S. House of Representatives. The bill will also end Affordable Care Act coverage for millions, allow out-of-pocket healthcare costs to increase, and cut Medicare spending by \$500 billion. Overall, 16 million people will lose healthcare, with 551,000 individuals dying unnecessarily each year. 40

The bill will cause **123,000 people in Arkansas to lose coverage from Arkansas Medicaid** (the state's Medicaid program). <sup>41</sup> Arkansas will lose \$8,874,000,000 in Medicaid funding. <sup>42</sup> That money could be made up through firing public service workers, raising your taxes by more than 5%, or reducing funding for schools and law enforcement.

people with disabilities, veterans, new mothers, retirees, students and low wage workers.

In Arkansas, 740,193 people are supported by Medicaid. <sup>43</sup> This includes 41% percent of moms giving birth, <sup>44</sup> 47% percent of children <sup>45</sup> and 67% percent of grandparents and other seniors in nursing homes in Arkansas. <sup>46</sup> Medicaid also supports veterans, students, working families and AFT members.



# medicaid is the LARGEST

health insurance provider for children in the United States and covers about half of all kids.

School health professionals, like speech pathologists, occupational therapists and school nurses and psychologists, all rely on Medicaid funding. Without Medicaid, they will not be able to help as many of the 80,000 students in Arkansas schools with disabilities.<sup>47</sup>

Medicaid accounts for 19 percent of all payments to hospitals nationwide. 48 Cuts could lead to longer wait times, rushed care, hospital closures and an increase in workplace violence and other challenges faced by our healthcare members. Rural areas and small towns could be impacted the worst, with families having to travel hours for maternity or cancer care. 49



Arkansas receives \$7,305,000,001 in federal Medicaid funding annually. <sup>50</sup> Gutting Medicaid will mean **job losses**—in hospitals, in schools and to Arkansas public service jobs.

We're in this fight together.
