STATE MEDICAID FACTS

Protect Your Healthcare, Schools and Hospitals

The U.S. Senate is moving to approve **\$800 billion in cuts** to Medicaid that have already passed the U.S. House of Representatives. The bill will also end Affordable Care Act coverage for millions, allow out-of-pocket healthcare costs to increase, and cut Medicare spending by \$500 billion. Overall, 16 million people will lose healthcare, with 551,000 individuals dying unnecessarily each year.⁵³⁴

The bill will cause **13,000 people in South Dakota to lose coverage from South Dakota Medicaid** (the state's Medicaid program).⁵³⁵ South Dakota will lose \$931,000,000 in Medicaid funding.⁵³⁶ That money could be made up through firing public service workers, raising your taxes by more than 5%, or reducing funding for schools and law enforcement.

people with disabilities, veterans, new mothers, retirees, students and low wage workers.

In South Dakota, 125,474 people are supported by Medicaid. 537 This includes 26% percent of moms giving birth, 538 30% percent of children 539 and 49% percent of grandparents and other seniors in nursing homes in South Dakota. 540 Medicaid also supports veterans, students, working families and AFT members.



medicaid is the LARGEST

health insurance provider for children in the United States and covers about half of all kids.

School health professionals, like speech pathologists, occupational therapists and school nurses and psychologists, all rely on Medicaid funding. Without Medicaid, they will not be able to help as many of the 23,000 students in South Dakota schools with disabilities.⁵⁴¹

Medicaid accounts for 19 percent of all payments to hospitals nationwide. ⁵⁴² Cuts **could lead to longer wait times, rushed care, hospital closures** and an increase in workplace violence and other challenges faced by our healthcare members. Rural areas and small towns could be impacted the worst, with families having to travel hours for maternity or cancer care. ⁵⁴³



South Dakota receives \$860,000,001 in federal Medicaid funding annually. ⁵⁴⁴ Gutting Medicaid will mean **job losses**—in hospitals, in schools and to South Dakota public service jobs.

We're in this fight together.
