STATE MEDICAID FACTS

Protect Your Healthcare, Schools and Hospitals

The U.S. Senate is moving to approve **\$800 billion in cuts** to Medicaid that have already passed the U.S. House of Representatives. The bill will also end Affordable Care Act coverage for millions, allow out-of-pocket healthcare costs to increase, and cut Medicare spending by \$500 billion. Overall, 16 million people will lose healthcare, with 551,000 individuals dying unnecessarily each year. ⁵⁴⁷

The bill will cause **68,000 people in Tennessee to lose coverage from TennCare** (the state's Medicaid program). ⁵⁴⁸ Tennessee will lose \$6,026,000,000 in Medicaid funding. ⁵⁴⁹ That money could be made up through firing public service workers, raising your taxes by more than 5%, or reducing funding for schools and law enforcement.

people with disabilities, veterans, new mothers, retirees, students and low wage workers.

In Tennessee, 1,271,910 people are supported by Medicaid. ⁵⁵⁰ This includes 46% percent of moms giving birth, ⁵⁵¹ 42% percent of children ⁵⁵² and 57% percent of grandparents and other seniors in nursing homes in Tennessee. ⁵⁵³ Medicaid also supports veterans, students, working families and AFT members.



medicaid is the LARGEST

health insurance provider for children in the United States and covers about half of all kids.

School health professionals, like speech pathologists, occupational therapists and school nurses and psychologists, all rely on Medicaid funding. Without Medicaid, they will not be able to help as many of the 132,000 students in Tennessee schools with disabilities.⁵⁵⁴

more emergencies, less staff

More patients will use the ER in place of primary care, and staffing and workplace violence in hospitals will worsen if Medicaid funding is cut.

Medicaid accounts for 19 percent of all payments to hospitals nationwide. 555 Cuts could lead to longer wait times, rushed care, hospital closures and an increase in workplace violence and other challenges faced by our healthcare members. Rural areas and small towns could be impacted the worst, with families having to travel hours for maternity or cancer care. 556



Tennessee receives \$9,533,000,000 in federal Medicaid funding annually. ⁵⁵⁷ Gutting Medicaid will mean **job losses**—in hospitals, in schools and to Tennessee public service jobs.

We're in this fight together.
