STATE MEDICAID FACTS

Protect Your Healthcare, Schools and Hospitals

The U.S. Senate is moving to approve **\$800 billion in cuts** to Medicaid that have already passed the U.S. House of Representatives. The bill will also end Affordable Care Act coverage for millions, allow out-of-pocket healthcare costs to increase, and cut Medicare spending by \$500 billion. Overall, 16 million people will lose healthcare, with 551,000 individuals dying unnecessarily each year. ⁵⁹⁹

The bill will cause **317,000 people in Virginia to lose coverage from Virginia Medicaid** (the state's Medicaid program). ⁶⁰⁰ Virginia will lose \$23,326,000,000 in Medicaid funding. ⁶⁰¹ That money could be made up through firing public service workers, raising your taxes by more than 5%, or reducing funding for schools and law enforcement.

people with disabilities, veterans, new mothers, retirees, students and low wage workers.

In Virginia, 1,613,039 people are supported by Medicaid. 602 This includes 35% percent of moms giving birth, 603 31% percent of children 604 and 62% percent of grandparents and other seniors in nursing homes in Virginia. 605 Medicaid also supports veterans, students, working families and AFT members.

health insurance provider for children in the United States and covers about half of all kids.

School health professionals, like speech pathologists, occupational therapists and school nurses and psychologists, all rely on Medicaid funding. Without Medicaid, they will not be able to help as many of the 178,000 students in Virginia schools with disabilities. 606

more emergencies, less staff

More patients will use the ER in place of primary care, and staffing and workplace violence in hospitals will worsen if Medicaid funding is cut.

Medicaid accounts for 19 percent of all payments to hospitals nationwide. 607 Cuts could lead to longer wait times, rushed care, hospital closures and an increase in workplace violence and other challenges faced by our healthcare members. Rural areas and small towns could be impacted the worst, with families having to travel hours for maternity or cancer care. 608



Virginia receives \$14,380,000,001 in federal Medicaid funding annually. ⁶⁰⁹ Gutting Medicaid will mean **job losses**—in hospitals, in schools and to Virginia public service jobs.
