STATE MEDICAID FACTS

Protect Your Healthcare, Schools and Hospitals

The U.S. Senate is moving to approve **\$800 billion in cuts** to Medicaid that have already passed the U.S. House of Representatives. The bill will also end Affordable Care Act coverage for millions, allow out-of-pocket healthcare costs to increase, and cut Medicare spending by \$500 billion. Overall, 16 million people will lose healthcare, with 551,000 individuals dying unnecessarily each year. 612

The bill will cause **490,000 people in Washington to lose coverage from Apple Health** (the state's Medicaid program). ⁶¹³ Washington will lose \$36,172,000,000 in Medicaid funding. ⁶¹⁴ That money could be made up through firing public service workers, raising your taxes by more than 5%, or reducing funding for schools and law enforcement.

people with disabilities, veterans, new mothers, retirees, students and low wage workers.

In Washington, 1,779,850 people are supported by Medicaid. 615
This includes 35% percent of moms giving birth, 616 38% percent of children 617 and 59% percent of grandparents and other seniors in nursing homes in Washington. 618 Medicaid also supports veterans, students, working families and AFT members.

health insurance provider for children in the United States and covers about half of all kids.

School health professionals, like speech pathologists, occupational therapists and school nurses and psychologists, all rely on Medicaid funding. Without Medicaid, they will not be able to help as many of the 152,000 students in Washington schools with disabilities. 619

More patients will use the ER in place of primary care, and staffing and workplace violence in hospitals will worsen if Medicaid funding is cut.

Medicaid accounts for 19 percent of all payments to hospitals nationwide. 620 Cuts could lead to longer wait times, rushed care, hospital closures and an increase in workplace violence and other challenges faced by our healthcare members. Rural areas and small towns could be impacted the worst, with families having to travel hours for maternity or cancer care. 621



Washington receives \$12,847,000,001 in federal Medicaid funding annually. ⁶²² Gutting Medicaid will mean **job losses**—in hospitals, in schools and to Washington public service jobs.

We're in this fight together.
