## Protect Your Healthcare, Schools and Hospitals

Congress is moving to approve \$600-\$800 billion in funding cuts to the Medicaid program. Millions of people could lose their healthcare under the plan being pushed through Congress.



In Wisconsin, 1,111,757 people are supported by Medicaid.<sup>1</sup> This includes 35% percent of moms giving birth,<sup>2</sup> 33% percent of children<sup>3</sup> and 55% percent of grandparents and other seniors in nursing homes in Wisconsin.<sup>4</sup> Medicaid also supports veterans, students, working families and AFT members.



Medicaid accounts for 19 percent of all payments to hospitals nationwide.<sup>5</sup> Cuts could lead to longer wait times, rushed care, hospital closures and an increase in workplace violence and other challenges faced by our healthcare members. Rural areas and small towns could be impacted the worst, with families having to travel hours for maternity or cancer care.<sup>6</sup>



#### medicaid is the LARCEST health insurance provider for children in the United States and covers about half of all kids.

School health professionals, like speech pathologists, occupational therapists and school nurses and psychologists, all rely on Medicaid funding. Without Medicaid, they will not be able to help as many of the 125,000 students in Wisconsin schools with disabilities.<sup>7</sup>



Wisconsin receives \$8,157,000,000 in federal Medicaid funding annually.<sup>8</sup> Gutting Medicaid will mean **job losses**—in hospitals, in schools and to Wisconsin public service jobs.

We're in this fight together. Bipartisan groups representing state legislators, state governments, county managers and cities are concerned about the fate of Medicaid.<sup>9</sup> And 71 percent of voters who supported President Trump oppose cuts to Medicaid.<sup>10</sup> We need you to tell the political leaders and donors in Washington, D.C., to keep their hands off of Wisconsin Medicaid: www.actionnetwork.org/letters/medicaid-cuts-2025.
